

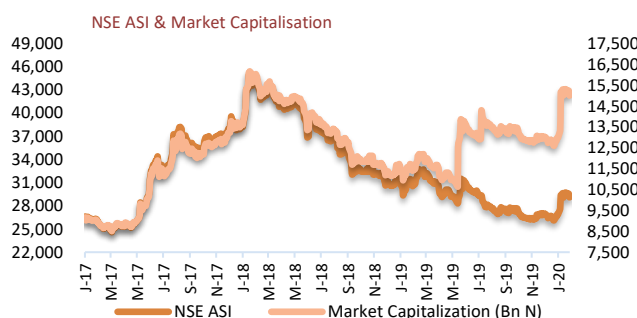


# Cowry Daily Market Insight 28 May 2020

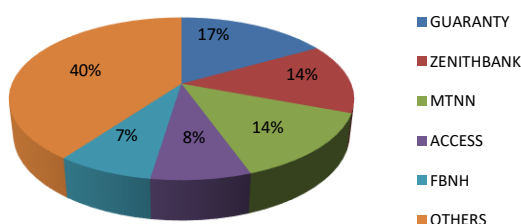

## Domestic Equities Falls by 0.22% amid Renewed Bearish Activity; NIBOR Declines for All Tenor Buckets amid Renewed Liquidity Ease.....

The Local Bourse All Share Index (ASI) dwindled by 0.22% amid renewed profit taking activity despite the Exchange printing 18 gainers against 17 losers at the close of trade. Hence, the year to date loss of the NSE ASI rose to 6.24%, Share prices of tickers such as ZENITHBANK, FLOURMILL and OANDO tanked by 2.51%, 4.76% and 5.71% respectively. Similarly, the NSE Banking, NSE Consumer Goods and NSE Oil/Gas indices dipped by 2.79%, 0.07% and 0.63% respectively. Meanwhile, market activity was weak as the volume and value of stocks traded dwindled by 40.13% and 38.60% to 0.34 billion units and N3.46 billion. Elsewhere, NIBOR declined for all tenor buckets amid renewed liquidity ease; however, NITTY was flattish for all maturities. In the OTC bonds market, the values of FGN bonds were flattish for all maturities tracked; however, FGN Eurobond declined for most maturities tracked amid renewed bearish activity.
