



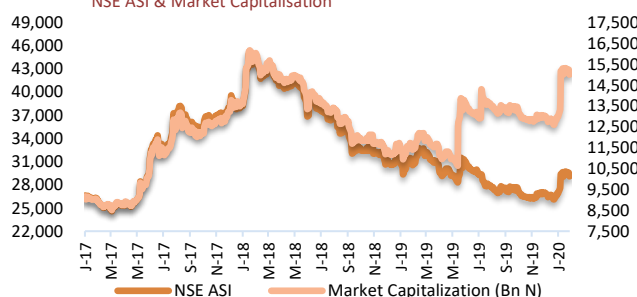

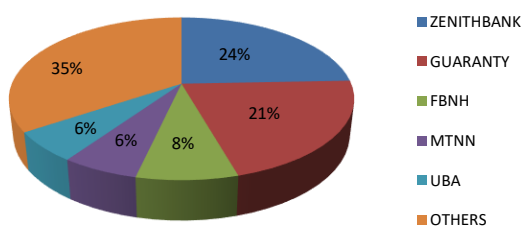
Domestic Equities Market Declines by 0.91% amid Sustained Bearish Activity; NIBOR Declines for All Tenor Buckets amid Sustained Liquidity Ease.....

The Local Bourse All Share Index (ASI) tanked by 0.91% amid sustained profit taking activity even as the Exchange printed 25 losers as against 16 gainers at the close of trade. Specifically, Tickers such as MTNN, BUACEMENT and ZENITHBANK suffered setback as their respective share prices moderated by 1.69%, 1.81% and 2.70%. Similarly, most sub-sector gauges closed in negative territory, save the NSE Insurance index which rose by 0.88%. The NSE Banking, NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices plummeted by 1.93%, 0.03%, 0.33% and 1.44% respectively, Hence, the year to date loss of the NSE ASI worsened to 7.03%. Meanwhile, market activity waned as the volume and value of stocks traded dipped by 29.51% and 52.74% to 0.23 billion units and N1.6 billion respectively. Elsewhere, NIBOR declined for all tenor buckets amid sustained liquidity ease; however, NITTY moved in mixed directions across maturities. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, FGN Eurobond declined for most maturities tracked.
