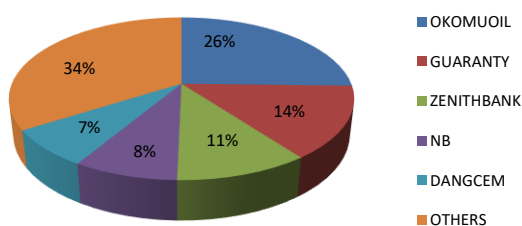
Local Bourse Declines by 0.43% amid Sustained Bearish Activity; NIBOR Falls for Most Tenor Buckets amid Renewed Liquidity Ease.....

The Local Bourse closed the week on a negative note as its All Share Index (ASI) dwindled by 0.43% amid sustained profit taking activity even as the number of losers (21) outweighed the number of gainers (13) at the close of trade. Hence, the year to date loss of the NSE ASI rose to 7.50%. Given the sell pressure on large cap stocks such as DANGCEM, OKOMO OIL, ACCESS and GUINNESS, their respective share prices dipped by 6.47%, 4.48%, 0.74% and 2.86%. Similarly, the NSE Banking, NSE Insurance, NSE Consumer Goods and NSE Oil/Gas indices moderated by 0.22%, 0.14%, 0.21% and 0.05% respectively. Meanwhile, market activity was weak as the volume and value of stocks traded dipped by 3.32% and 11.95% to 0.16 billion units and N1.9 billion respectively. Elsewhere, NIBOR declined for most tenor buckets amid renewed liquidity ease; however, NITTY rose for most maturities. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, FGN Eurobond rose for most maturities tracked amid renewed bullish activity.
