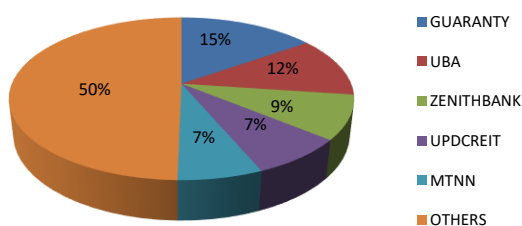
Domestic Bourse Index Rebounds by 0.47% amid Renewed Bullish Activity; NIBOR Declines for All Tenor Buckets amid Renewed Liquidity Ease.....

The local bourse All Share Index (ASI) rose by 0.47% amid renewed bullish activity; albeit, the numbers of losers (22) outweighed the number of gainers (12) at the close of the trading session. Hence, the year to date loss of the NSE ASI moderated to 8.37%. Investor's buy interest in Tickers such as BUACEMENT, CADBURY and OANDO lifted their respective prices by 8.53%, 9.63% and 3.48%. However, performance across sub-sectors were bearish as three out of the five Indices tracked closed southwards; the NSE Banking, NSE Insurance and NSE Consumer Goods indices declined by 0.88%, 0.79% and 0.47% respectively. On the flip side, the NSE Oil/Gas and NSE Industrial indices rose by 0.30% and 1.35% respectively. Elsewhere, NIBOR declined for all tenor buckets amid renewed liquidity ease; however, NITTY moved in mixed directions across maturities tracked despite lower stop rates at the primary market. Stop rates for 91-Day, 182-Day and 364-Day fell to 1.798%, 1.91% and 3.39%. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, FGN Eurobond rose for most maturities.
