



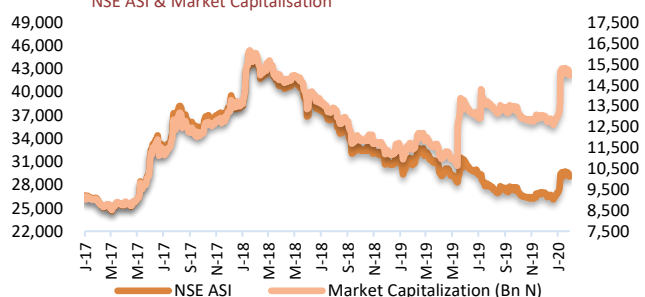

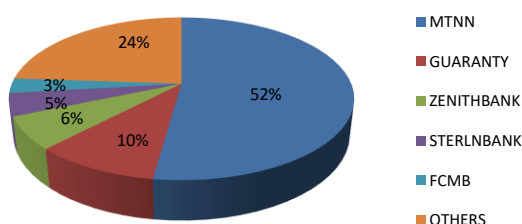
Local Equities Market Index Falls by 0.44% amid Renewed Bearish Activity; NIBOR Declines for Most Tenor Buckets amid Sustained Liquidity Ease...

The local bourse started the week on a negative note as its All Share Index (ASI) shed 0.44% amid renewed profit taking activity. Hence, the year to date loss of the NSE ASI rose to 9.84%. Similarly, the exchange recorded 17 losers as against 14 gainers at the close of trade. Specifically, bellwethers such as MOBIL, MTNN, ZENITHBANK and GUARANTY dwindled by 9.97%, 0.95%, 2.99 and 2% respectively as investors took profit following the recent bullish run. Three of the five sub-sectors were bearish: the NSE Oil/Gas index led the laggards by 1.75%, followed by the NSE Banking and NSE Insurance indices by 1.70% and 0.35% respectively. On the flip side, the NSE Industrial index rose by 0.26% while the NSE Consumer Goods index closed flat. Meanwhile, the volume and value of stocks traded rose by 75.67% and 139.55% to 0.23 billion units and N2.15 billion respectively. Elsewhere, NIBOR and NITTY moderated for most tenor buckets amid sustained liquidity ease. In the OTC bonds market, the values of FGN bonds were flattish for most maturities; however, FGN Eurobond rose for most maturities tracked.
