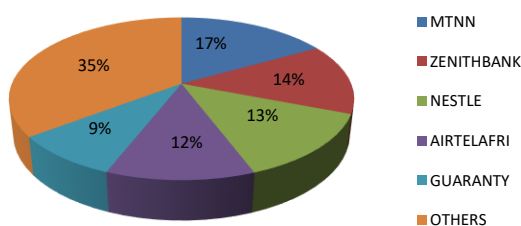
Local Equities Market Index Rebounds by 0.06% amid Renewed Bullish Activity; NIBOR Rose for All Tenor Buckets amid Renewed Liquidity Strain...

The local bourse closed in positive territory for the first time this week as its All Share Index (ASI) rose marginally by 0.06% amid renewed bargain hunting activity; albeit the number of losers (15) outweighed the number of gainers (11) at the sound of gong today. Hence, the year to date loss of the NSE ASI moderated to 10.10%. We saw share prices of AIRTELAFRI, ACCESS and GUARANTY appreciate by 3.4%, 0.8% and 0.9% respectively amid buy pressure. Performance across sub-sector gauges was weak as only two out of five indices tracked closed in green territory: the NSE Banking and NSE Industrial rose by 0.37% and 0.01% respectively. However, the NSE Insurance and NSE Consumer Goods Indices dwindled by 0.89% and 1.39% respectively while the NSE Oil/Gas closed flat. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; however, NITTY declined for maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, FGN Eurobond rose for most maturities tracked.
