

Domestic Equities Market Index Advances by 0.83% amid Sustained Bullish Activity; NIBOR Declines for All Tenor Buckets amid Renewed Liquidity Ease... The local bourse All Share Index (ASI) increased by 0.83% amid sustained bargain hunting activity even as the Exchange printed 17 gainers as against 16 losers at the close of trading session. Hence, the year to date loss of the NSE ASI declined to 9.35%. Specifically, share prices of Tickers such as AIRTELAFRI, MTNN and GUARANTY rose by 2.35%, 2.61% and 2.33%. However, only two out of five indices tracked closed in green territory - the NSE Banking and NSE Insurance rose. Their respective indices rose by 0.08% and 0.01% respectively. On the flip side, the NSE Consumer Goods and NSE Oil/Gas Indices tanked by 0.46% and 0.22% respectively while the NSE Industrial index closed flat. Elsewhere, NIBOR moderated for most tenor buckets amid renewed liquidity ease. However, NITTY declined for most maturities tracked in tandem with the declining stop rates which fell for all maturities. Stop rates for 91-Day, 182-Day and 364-Day fell to 1.3%, 1.8% and 3.35% respectively. In the OTC bonds market, the values of FGN bonds declined for most maturities tracked; however, FGN Eurobond moderated for most maturities
