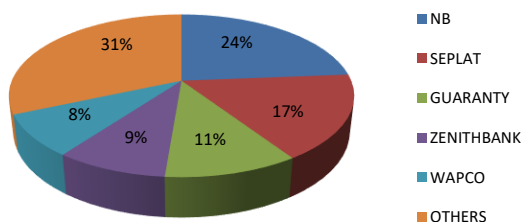
Lagos Bourse Index Falls by 0.17% amid Renewed Bearish Activity; NIBOR Rises for Most Tenor Buckets amid Renewed Liquidity Strain...

The local bourse closed the week on a negative note as its All Share Index (ASI) declined by 0.17% amid renewed profit taking activity even as the Exchange printed 12 losers as against 10 gainers at the close of trading session. Hence, the year to date loss of the NSE ASI rose to 9.51%. Similarly, the NSE Banking, NSE Insurance and NSE Consumer Goods Indices dwindled by 0.81%, 0.87% and 0.51% respectively amid sell pressure on tickers such as GUARANTY, LINKASSURE, NB and DANGSUGAR. Their respective share prices dipped by 2.27%, 9.09%, 2.28% and 1.64% respectively. On the other hand, the NSE Oil/Gas index rose by 0.62%; while the NSE Industrial index closed flat. Meanwhile, the volume of stocks traded dipped by 22.61% to 0.16 billion units; however, the value of stocks traded rose by 49.08% to N1.4 billion. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain. However, NITTY declined for all maturities tracked amid demand pressure. In the OTC bonds market, the values of FGN bonds declined for most maturities tracked; however, FGN Eurobond rose for most maturities tracked.
