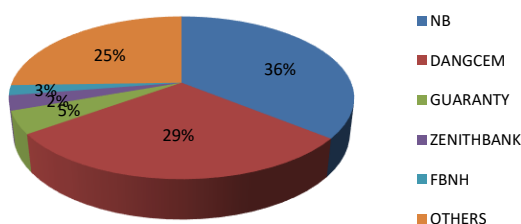
**Bearish Sentiments Halts as Domestic Equities Market Index Closes Flat; NIBOR Declines for All Tenor Buckets amid Renewed Liquidity Ease ...**

At the close of Wednesday's trading session, the local bourse All Share Index (ASI) closed flat at 24,173.53 points even as the Exchange recorded an equal number of gainers and losers (9) each. Hence, the year to date loss of the NSE ASI stood at 9.9%. Specifically, shares of Tickers such as ETERNA, MAYBAKER and FIDSON rose by 8.89%, 7.91% and 0.10% respectively. Performance across sub-sector gauges tracked was mixed as the NSE Banking and NSE Insurance indices moderated by 0.03%, 0.64% respectively while the NSE Oil/Gas rose by 0.04%. However, the NSE Consumer Goods and NSE Industrial indices closed flat. Meanwhile, market activity was upbeat as the volume and value of stocks traded rose by 32.37% and 39.24% to 0.40 billion units and N4.5 billion respectively. Elsewhere, NIBOR and NITTY declined for all maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, FGN Eurobond rose for most maturities tracked amid demand pressure.
