

Domestic Equities Market Index Climbs by 140bps amid Renewed Bullish Activity; NIBOR Declines for Most Tenor Buckets amid Sustained Liquidity Ease... The local bourse All Share Index (ASI) rose by 1.40% amid renewed bullish sentiment even as the Exchange printed an equal number of gainers and losers (11) each at the close of trading session. Hence, the year to date loss of the NSE ASI moderated to 8.68%. Amid the demand for some bellwether stocks such as DANGCEM, MTNN and ACCESS, we saw their share prices rise by 10%, 0.84% and 0.81% respectively. However, performance across sub-sectors failed to mirror general market performance as three of the five indices tracked closed in red. The NSE Banking, NSE Consumer Goods and NSE Oil/Gas indices dwindled by 0.08%, 0.23% and 0.04% respectively; while the NSE Insurance and NSE Industrial indices rose by 0.12% and 3.26% respectively. Meanwhile, market activity was weak as the volume and value of stocks traded tanked by 59.20% and 53.32% to 0.16 billion units and N2.1 billion respectively. Elsewhere, NIBOR declined for most tenor buckets amid sustained liquidity ease; however, FGN Eurobond rose for most maturities.
