






Nigerian Equities Market Index Rebounds by 0.18% amid Renewed Bullish Activity; NIBOR Declines for All Tenor Buckets amid Sustained Liquidity Ease...

The Lagos bourse All Share Index (ASI) rose by 0.18% amid renewed bargain hunting activity even as the Exchange printed 18 (gainers) as against 14 (losers) at the close of trading session. Hence, the year to date loss of the NSE ASI moderated to 8%. Sentiment was positive in the market as Tickers such as SEPLAT, BUACEMENT, UACN and PRESTIGE advanced by 10%, 1.03%, 2.94% and 8.70%; hence lifting the NSE Oil/Gas, NSE Industrial, NSE Consumer Goods and NSE Insurance indices by 4.58%, 0.27%, 0.51% and 1.40% respectively. On the flip side, the NSE Banking index declined by 0.21%. Meanwhile, market activity was weak as the volume and value of stocks dipped by 32.45% and 50.78% to 0.10 billion units and N0.97 billion respectively. Elsewhere, NIBOR declined for all tenor buckets amid sustained liquidity ease; also, NITTY moderated for all maturities tracked in tandem with the declining stop rates. Stop rates for the 91-Days, 182-Days and 364-Days moderated to 1.2%, 1.5% and 3.5% respectively. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, FGN Eurobond declined for most maturities tracked.
