

Nigerian Equities Market Index Advances by 0.29% amid Sustained Bullish Activity; NIBOR Rises for All Tenor Buckets amid Renewed Liquidity Strain... The Lagos bourse resumed the week positively as its All Share Index (ASI) rose by 0.29% to 24,766.12 points amid sustained bargain hunting activity. Also, the Exchange recorded 19 (gainers) as against 16 (losers) at the close of trading session. Hence, the year to date loss of the NSE ASI moderated to 7.7%. Market sentiment was positive despite the mixed H1 2020 financial performance of companies. Specifically, Tickers such as Guaranty, Flour Mill and BUACEMENT gained 1.56%, 9.97% and 2.03% respectively; hence lifting the NSE Banking, NSE Consumer Goods and NSE Industrial indices by 0.70%, 0.13% and 0.78% respectively. On the flip side, the NSE Insurance dipped by 2.35% while the NSE Oil/Gas closed flat. Meanwhile, the volume and value of stocks rose by 83.57% and 34.52% to 0.18 billion units and N1.39 billion respectively. Elsewhere, NIBOR rose for all tenor buckets amid renewed liquidity strain; however, NITTY moderated for most maturities tracked. In the OTC bonds market, the values of FGN bonds declined for most maturities tracked; however, FGN Eurobond rose for most maturities tracked amid demand pressure.
