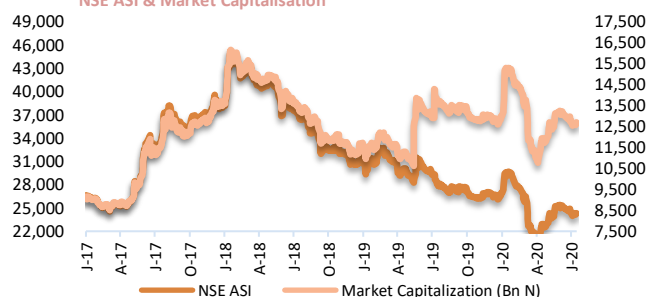




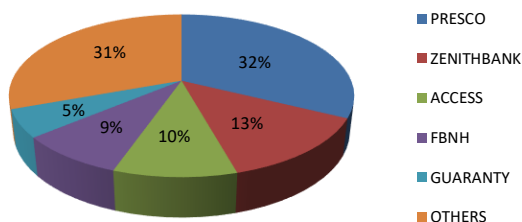
Local Equities Market Index Gains 0.16% amid Sustained Bullish Activity; NIBOR Rises for Most Tenor Buckets amid Renewed Liquidity Strain...

At the close of Wednesday's trade, the Lagos bourse All Share Index (ASI) rose by 0.16% amid sustained bargain hunting activity even as the Exchange printed 18 (gainers) as against 12 (losers). Consequently, the year to date loss of the NSE ASI moderated to 7.3%. Specifically, buy sentiments in Tickers such as MOBIL, CAP, STANBIC and GUARANTY rocketed their respective share prices by 0.92%, 9.74%, 5% and 1.94%. Similarly, the sub-sector gauges tracked closed in green territory save for the NSE Insurance index which moderated by 0.01%. The NSE Banking, NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices rose by 0.07%, 0.01%, 0.11% and 0.01% respectively. Meanwhile, market activity was upbeat as the volume and value of stocks ballooned by 148.14% and 167.07% to 0.38 billion units and N3.8 billion. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; also, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, FGN Eurobond rose for most maturities tracked amid demand pressure.
