

Local Equities Market Index Rises by 0.19% amid Sustained Bullish Activity; NIBOR Declines for All Tenor Buckets amid Renewed Liquidity Ease... The Lagos bourse rose for the fourth consecutive session this week as its All Share Index (ASI) further gained 0.19% amid sustained bargain hunting activity. Consequently, the year to date loss of the NSE ASI moderated to 7.1%. Also, the Exchange printed 20 (gainers) as against 10 (losers) as blue-chip stocks such as SEPLAT, STANBIC, MTNN and ZENITHBANK appreciated by 9.03%, 4.76%, 0.42% and 1.21% respectively amid investor's demand. Similarly, performance across sub-sector gauges was bullish as three out of the five indices tracked closed in green: the NSE Oil/Gas index advanced the most by 4.36%, followed by the NSE Banking and NSE Consumer Goods indices by 0.14% and 0.09% respectively. However, the NSE Insurance and NSE Industrial indices moderated by 0.67% and 0.02% respectively. Meanwhile, market activity was weak as the volume and value of stocks declined by 54.67% and 45.21% to 0.17 billion units and N2.1 billion. Elsewhere, NIBOR and NITTY fell for most tenor buckets amid renewed liquidity ease. In the OTC bonds market, the values of FGN bonds was flattish for most maturities tracked; however, FGN Eurobond declined for most maturities tracked.
