

Local Equities Market Index Advances by 0.45% amid Sustained Bullish Activity; NIBOR Declines for All Tenor Buckets amid Renewed Liquidity Ease... The Lagos bourse sustained its positive performance in the just concluded week as its All Share Index (ASI) further increased by 0.45% to close at 25,041.89 points at the close of trading session. Also, the Exchange recorded 23 (gainers) as against 5 (losers). Hence, the year to date loss of the NSE ASI eased to 6.7%. Notably, the NSE Banking index rose by 2.38% as demand for Tier 1 Bank stocks such as ZENITHBANK, ACCESS, UBA and GUARANTY lifted their respective share prices by 1.20%, 2.36%, 1.55% and 2.53%. Also, the sub-sector gauges tracked closed in green save the NSE Insurance index which moderated by 0.53%. The NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices climbed by 0.42%, 0.08% and 0.02% respectively. Meanwhile, market activity was weak as the volume and value of stocks declined by 3.80% and 5.97% to 0.16 billion units and N2 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; however, NITTY moderated for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked while the FGN Eurobond rose for most maturities tracked.
