



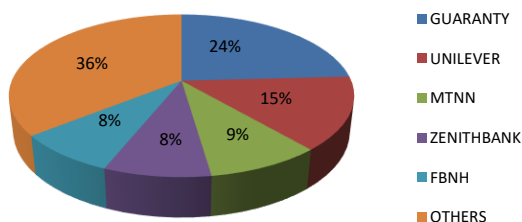
## Local Equities Market Index Shed 0.06% amid Renewed Bearish Activity; NIBOR Declines for All Tenor Buckets amid Sustained Liquidity Ease...

The Lagos bourse started the week on a negative note as its All Share Index (ASI) fell lower by 0.06% to close at 25,041.89 points; albeit the number of gainers (18) outweighed that of the losers (11) at the close of the trading session. Hence, the year to date loss of the NSE ASI rose to 6.7%. Specifically, the NSE Banking and NSE Industrial indices tanked by 0.04% and 0.41% as investors dumped some of their blue-chip shares such as BUACEMENT, ZENITHBANK and UBA. Hence, their respective share prices fell by 1.39%, 0.59% and 1.53%. However, performance across sub-sector gauges tracked was positive as three out of the five indices tracked closed in green: the NSE Insurance, NSE Consumer Goods and NSE Oil/Gas indices rose by 0.96%, 0.33% and 0.08% respectively. Meanwhile, the volume of stocks rose by 4.90% to 0.17 billion units while the value of stocks declined by 28.92% to N1.4 billion. Elsewhere, NIBOR moderated for most tenor buckets amid renewed liquidity ease; however, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; also, FGN Eurobond rose for most maturities tracked.
