





Local Equities Market Index Declines by 0.58% amid Sustained Bearish Activity; NIBOR Moderates for All Tenor Buckets amid Sustained Liquidity Ease...

The Lagos bourse All Share Index (ASI) dwindled by 0.58% to close at 25,041.89 points amid sustained profit taking activity even as the Exchange printed equal numbers (17) of gainers and losers at the close of the trading session. Hence, the year to date loss of the NSE ASI worsened to 7.2%. Given the sell-offs in shares of DANGCEM, MANSARD and GUINNESS, their respective prices moderated by 4.09%, 8.23% and 3.33%. However, sub-sector gauges didn't mirror the market performance as most sectors tracked closed in green: the NSE Banking, NSE Consumer Goods and NSE Oil/Gas indices closed higher by 0.52%, 0.93% and 0.26% respectively. On the flip side, the NSE Insurance and NSE Industrial indices lost 2.48% and 2.16% respectively. Meanwhile, market activity was upbeat as the volume and value of stocks traded rose by 23.62% and 23.42% to 0.20 billion units and N2.4 billion. Elsewhere, NIBOR moderated for most tenor buckets amid sustained liquidity ease; however, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds declined for most maturities tracked; however, FGN Eurobond rose for most maturities tracked.
