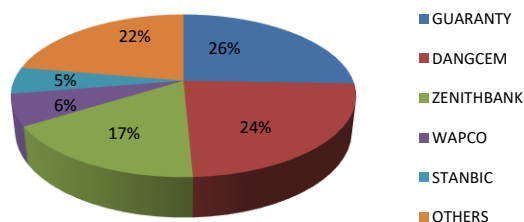
Domestic Equities Market Index Declines by 0.22% amid Sustained Bearish Activity; NIBOR Rises for Most Tenor Buckets amid Sustained Liquidity Strain...

The Lagos bourse resumed the week in negative territory as its All Share Index (ASI) moderated by 0.22% amid sustained profit taking activity; albeit the number of gainers (17) outweighed the numbers of losers (15) at the close of trading session. Hence, the year to date loss of the NSE ASI rose to 6.3%. Sentiment was negative in the market as share prices of GUARANTY, ETI and DANGCEM fell by 0.74%, 1.23% and 0.20% respectively. Similarly, the NSE Banking and the NSE Industrial indices tanked by 0.24% and 0.38% respectively. On the other hand, the NSE Insurance, NSE Consumer Goods and NSE Oil/Gas indices rose by 2.89%, 0.23% and 0.49% respectively. However, market activity was weak as the total volume and value of stocks traded nosedived by 66.59% and 59.20% to 0.16 billion units and N1.8 billion. Elsewhere, NIBOR rose for most tenor buckets amid sustained liquidity strain; however, NITTY declined for most maturities tracked amid demand pressure. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, FGN Eurobond declined for most maturities tracked.
