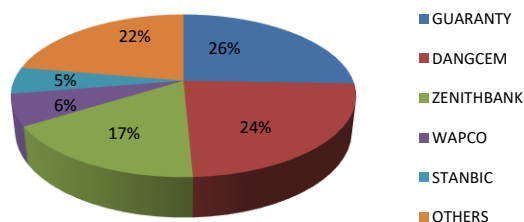
Domestic Equities Market Index Rebounds by 0.02% amid Renewed Bullish Activity; NIBOR Declines for All Tenor Buckets amid Renewed Liquidity Ease...

The Lagos bourse All Share Index (ASI) rose marginally by 0.02% amid renewed bargain hunting activity even as the Exchange printed 16 gainers as against 13 losers at the close of trading session. Hence, the year to date loss of the NSE ASI eased to 6.3%. Notably, the NSE Banking index rose by 0.58% buoyed by price appreciation in blue-chip stocks such as UBA, ZENITHBANK and GUARANTY. Their respective share prices rose by 2.31%, 0.30% and 0.20%. Also, the NSE Insurance rose by 0.89%. However, Performance across sub-sector gauges tracked closed southwards: the NSE Oil/Gas index led the laggards by 1.83% followed by the NSE Consumer Goods and NSE Industrial indices by 0.12% and 0.2% respectively. Meanwhile, market activity picked up as the total volume and value of stocks traded rose by 68.06% and 33.30% to 0.27 billion units and N2.4 billion. Elsewhere, NIBOR moderated for most tenor buckets amid renewed liquidity ease; however, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for maturities tracked; however, FGN Eurobond declined for most maturities tracked.
