## Cowry Daily Market Insight 19 August 2020


NSE All Share Index Revs by 0.14% on Banking Shares; NIBOR Moves in Mixed Directions across Tenor Buckets...

The domestic equities market index rose further by 0.14% amid sustained bargain hunting despite the Exchange printing same number of gainers and losers (13) at the close of trading session. Hence, the year to date loss of the NSE ASI lowered to 6.22%. Notably, the NSE Banking index rose by 0.81% as share prices of GUARANTY, ZENITHBANK and UBA further appreciated. Their respective share prices rose by 1.20%, 0.90% and 0.75%. Also, the NSE Insurance rose by 0.41% even as the NSE Consumer Goods index increased by 0.19%. However, the NSE Industrial indices moderated by 0.04% while the NSE Oil/Gas index remained flattish at 186.55 points. Meanwhile, market activity was weak as the total volume and value of stocks traded decreased by 33.58% and 37.56% to 0.18 billion units and N1.5 billion. Elsewhere, NIBOR moved in mixed directions across tenor buckets; however, NITTY rose for most maturities tracked amid renewed sell-offs. In the OTC bonds market, the values of FGN bonds were bearish for most maturities tracked; however, FGN Eurobond further declined for most maturities tracked amid sustained bearish activity.
