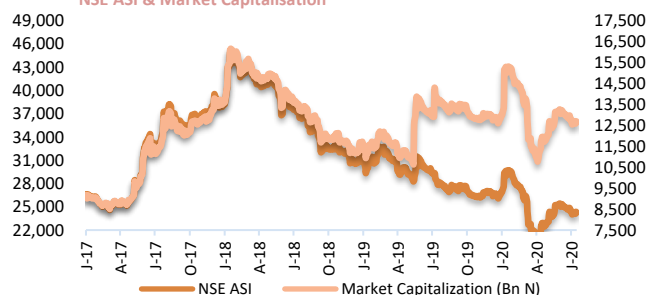


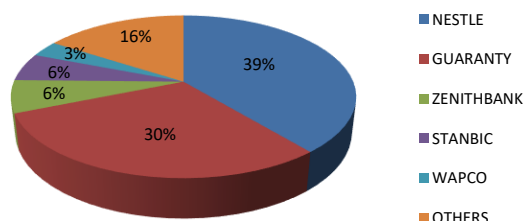
NSE All Share Index Climbs by 0.13% amid Sustained Bargain Hunting Activity; NIBOR Rises for Most Tenor Buckets on Renewed Liquidity Strain...

The local equities market index gained 0.13% amid sustained bargain hunting even as the Exchange recorded 17 gainers as against 11 losers at the close of trading session. Hence, the year to date loss of the NSE ASI eased to 6.10%. Similarly, Market capitalization rose by 0.14% to N13.14 trillion as Consolidated Hallmark Insurance listed a right issue of 2,032,500,000 ordinary shares of 50 kobo each at 52 kobo per share. We saw share prices of CAP, STANBIC and INTBREW appreciate by 5.56%, 1.47% and 10% respectively amid investor's demand. Of the five sub-sectors, the NSE Banking, NSE Consumer Goods and the NSE Industrial indices advanced by 0.18%, 0.52% and 0.03% respectively, while the NSE Insurance moderated by 0.23%; the NSE Oil/Gas index closed flat. Meanwhile, total value of stocks traded increased by 64.42% to N2.5 billion. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; however, NITTY moderated for most maturities tracked. In the OTC bonds market, the values of FGN bonds were bearish for most maturities tracked; also, FGN Eurobond further declined for most maturities tracked amid sustained bearish activity.
