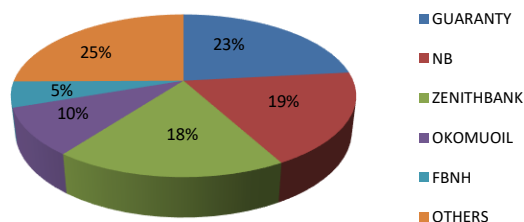
NSE All Share Index Advances by 0.07% amid Sustained Bargain Hunting Activity; NIBOR Declines for All Tenor Buckets amid Renewed Liquidity Ease...

The domestic equities market index further rose by 0.07% amid sustained bargain hunting even as the Exchange recorded 20 gainers as against 12 losers at the close of trading session. Hence, the year to date loss of the NSE ASI eased to 6.03%. Similarly, the NSE Consumer Goods index advanced the most by 1.06% as investors bought more of NB, INTBREW and UNILEVER. Their respective share prices rose by 2.86%, 9.09% and 1.45%. Also, the NSE Insurance and the NSE Oil/Gas indices rose by 0.39% and 0.43% respectively. On the flip side, the NSE Banking index dipped by 0.46% amid renewed sell-offs; while the NSE Industrial index closed flat. Meanwhile, market activity was weak as the total volume and value of stocks traded tanked by 11.66% and 30.56% to 0.15 billion units and N1.7 billion respectively. Elsewhere, NIBOR declined for all tenor buckets amid renewed liquidity ease; however, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, FGN Eurobond rose for most maturities tracked amid renewed demand pressure.
