

NSE All Share Index Rises by 0.03% amid Sustained Bargain Hunting Activity; NIBOR Declines for All Tenor Buckets amid Sustained Liquidity Ease... The domestic equities market resumed the week on a positive note as its ASI (All Share Index) rose marginally by 0.03% amid sustained bullish activity; albeit the Exchange recorded equal numbers of gainers (15) and losers (15) at the close of trading session. Hence, the year to date loss of the NSE ASI eased to 6.0% despite the contraction in Q2 2020 GDP figure. Sentiments was positive in the market as Tickers such as UNILEVER, GUINNESS and GUARANTY appreciated by 7.53%, 1.32% and 0.40% respectively. However, only two out of the five sub-sector gauges tracked closed in green; the NSE Insurance and NSE Consumer Goods indices rose by 0.82% and 0.70%. The NSE Banking and NSE Industrial indices eased by 0.01% and 0.10% respectively while the NSE Oil/Gas closed flat. Meanwhile, market activity picked up as the total volume and value of stocks traded rose by 58.36% and 34.56% to 0.25 billion units and N2.3 billion. Elsewhere, NIBOR declined for all tenor buckets amid sustained liquidity ease; however, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds was flattish for most maturities tracked; however, FGN Eurobond rose for most maturities.
