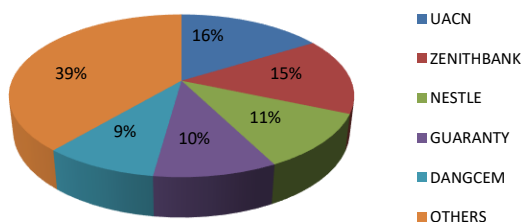
NSE All Share Index Climbs by 0.07% amid Sustained Bullish Activity; NIBOR Rises for Most Tenor Buckets amid Renewed Liquidity Strain...

The domestic equities market sustained its bullish momentum as its NSE ASI advanced by 0.07%; albeit the number of losers (19) outweighed that of the gainers (11) at the close of trading session. Hence, the year to date loss of the NSE ASI eased to 5.6%. Specifically, shares of MOBIL, DANCEM, WAPCO and BUACEMENT were the toast of investors; hence their respective prices rose by 10%, 0.52%, 3.46% and 0.25%. The NSE Oil/Gas and NSE Industrial indices rose by 1.99% and 0.55% respectively. However, performance across sub-sector gauges tracked was negatively skewed as three out of the five indices closed in red; the NSE Banking, NSE Insurance and NSE Consumer Goods indices moderated by 0.74%, 0.61% and 0.01%. Meanwhile, market activity was upbeat as total volume and value of stocks traded ballooned by 120.36% and 185.46% to 0.30 billion units and N2.62 billion. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; however, NITTY moved in mixed directions across maturities. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, FGN Eurobond rose for most maturities tracked amid demand pressure.
