






The NSE All Share Index Rises by 0.18% amid Sustained Bullish Activity; NIBOR Declines for Most Tenor Buckets amid Sustained Liquidity Ease...

The domestic equities market ASI advanced by 0.18% to 25,460 points amid sustained bargain hunting activity even as the Exchange printed 18 gainers against 11 losers at the close of trading session. Hence, the year to date loss of the NSE ASI lowered to 5.1%. Specifically, buy interest in tickers such as NB, STANBIC, ZENITHBANK and BUACEMENT lifted their respective share prices by 2.56%, 2.74%, 0.59% and 0.25%. However, performance was mixed across sub-sector gauges tracked as only the NSE Banking and NSE Consumer Goods indices rose by 0.36% and 0.55%. On the flip side, the NSE Insurance and NSE Oil/Gas indices moderated by 1.08% and 0.19% respectively while the NSE Industrial closed flat. Meanwhile, market activity was weak as the total volume and value of stocks traded dwindled by 83.33% and 53.33% to 0.17 billion units and N0.98 billion. Elsewhere, NIBOR declined for most tenor buckets amid sustained liquidity ease; however, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds moderated most maturities tracked; however, FGN Eurobond rose for most maturities tracked amid sustained demand pressure.
