### Cowry Daily Market Insight 15 September 2020

The NSE All Share Index Falls by 0.03% amid Renewed Bearish Activity; NIBOR Rises for Most Tenor Buckets amid Renewed Liquidity Strain... The domestic equities market NSE ASI declined by 0.03% to 25,597.96 points amid renewed profit taking activity even as the Exchange printed 15 losers as against 13 gainers at the close of trading session. Hence, the year to date loss of the NSE ASI rose to 4.6%. Specifically, Tickers such as ZENITHBANK, UBA, DANGSUGAR and SEPLAT moderated by 0.29%, 0.81%, 1.24% and 1.28% respectively as investors sold off part of their holdings. Notably, the NSE Oil/Gas index led the laggards by 1.16% followed by the NSE Banking and NSE Consumer Goods as their indices fell by 0.18% and 0.10% respectively. On the positive side, the NSE Insurance and NSE Industrial indices rose by 0.35% and 0.21% respectively. Meanwhile, market activity waned as the total volume and value of stocks traded fell by 4.63% and 9.25% to 0.24 billion units and N3.0 billion respectively. Elsewhere, NIBOR rose for all tenor buckets amid renewed liquidity strain; also, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, FGN Eurobond rose for most maturities tracked.
