The NSE All Share Index Declines by 0.19% amid Sustained Bearish Activity; NIBOR Rises for Most Tenor Buckets amid Sustained Liquidity Strain... The domestic equities market sustained its downtrend as its NSE ASI fell by 0.19% to 25,550.31 points even as the Exchange printed 18 losers as against 15 gainers at the close of trading session. Hence, the year to date loss of the NSE ASI rose to 4.8%. Given the sell pressure on CADBURY, WAPCO and ZENITHBANK, their respective share prices moderated by 8.39%, 3.70% and 1.16%. Similarly, performance across sub-sector gauges was bullish as three out of five indices closed southwards: the NSE banking, NSE Insurance and NSE Industrial indices declined by 0.58%, 1.49% and 0.23% respectively. On the positive side, the NSE Consumer Goods and NSE Oil/Gas indices rose by 0.07% and 0.41% respectively. Meanwhile, market activity waned as the total volume and value of stocks traded fell by 13.59% and 19.76% to 0.21 billion units and N2.4 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid sustained liquidity strain; also, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds was flattish for most maturities tracked; however, FGN Eurobond rose for most maturities tracked.
