



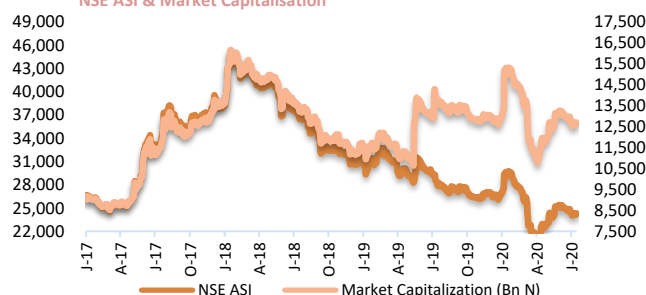

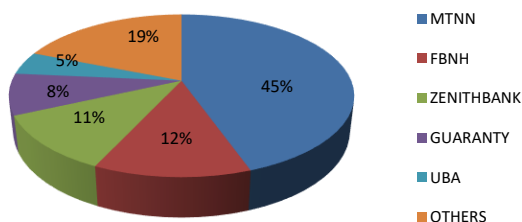
The NSE All Share Index Rises by 0.01% amid Sustained Bullish Activity; NIBOR Declines for All Tenor Buckets amid Sustained Liquidity Ease...

The domestic equities market NSE ASI rose marginally by 0.01% to 25,574.35 points amid sustained bargain hunting activity; albeit the number of losers (16) outweighed that of the gainers (9) at the close of trading session. Specifically, Tickers such as MTNN, UACN and GUARANTY were the toast of investors today as their respective share prices closed higher by 0.08%, 5.79% and 0.20%. However, performance was mixed as two out of the five indices tracked closed in green territory while the others moved in mixed directions; the NSE Insurance and NSE consumer Goods indices rose by 1.38% and 0.08% respectively. The NSE Banking index moderated by 0.09% while the NSE Oil/Gas and NSE Industrial indices closed flat. Meanwhile, market activity was upbeat as the total volume and value of stocks traded increased by 54.34% and 55.76% to 0.19 billion units and N1.7 billion. Elsewhere, NIBOR declined for all tenor buckets amid sustained liquidity ease; also, NITTY moderated for most maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish most maturities tracked; however, FGN Eurobond moderated for all maturities tracked.
