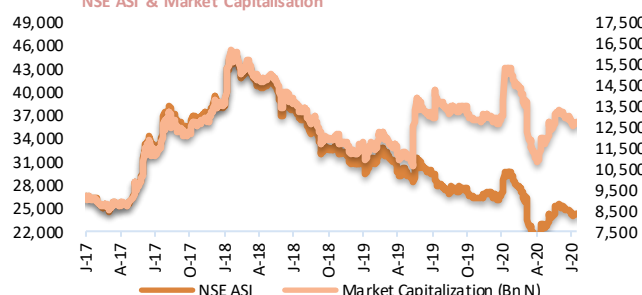




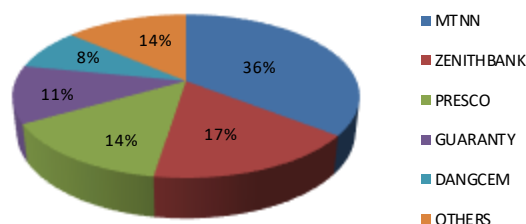
The NSE All Share Index Advances by 0.31% amid Sustained Bullish Activity; NIBOR Moves in Mixed Directions Across Tenor Buckets...

The domestic equities market sustained its bullish momentum as its NSE ASI gained 0.31% to 25,654.90 points; albeit the number of losers (14) outweighed that of the gainers (9) at the close of the trading session. Hence the year to date loss of the NSE ASI eased to 4.4%. Notably, we saw buy interest MTNN and FBNH as their respective share prices closed higher by 2.41% and 2.04% respectively. Despite the overall positive market mood, performance across sub-sectors gauges tracked was weak; the NSE Banking, the NSE Insurance, the Consumer Goods, the NSE Oil/Gas and NSE Industrial indices tanked by 0.60%, 1.11%, 0.10%, 0.15% and 0.11% respectively. Meanwhile, market activity was upbeat as the total volume and value of stocks traded increased by 33.61% and 154.61% to 0.26 billion units and N4.3 billion. Elsewhere, NIBOR and NITTY moved in mixed directions across tenor buckets. In the OTC bonds market, the values of FGN bonds were flattish most maturities tracked; however, FGN Eurobond moderated for all maturities tracked.
