The NSE All Share Index Gains 0.79% amid Sustained Bullish Activity; NIBOR Rises for Most Tenor Buckets amid Renewed Liquidity Strain... The domestic equities market ASI advanced by 0.79% to 25,987.14 points amid sustained bargain hunting activity even as the Exchange recorded 25 gainers as against 8 losers at the close of the trading session. Hence the year to date loss of the NSE ASI eased to 3.1%. Specifically, demand for blue-chip stocks such as DANGCEM, MTNN and GUARANTY lifted their respective share prices by 0.89%, 0.08% and 1.96%. Similarly, Performance across sub-sector gauges was bullish as three out of the five indices tracked closed in green: the NSE banking, NSE consumer Goods and NSE Industrial indices rose by 1.59%, 2.09% and 0.86% respectively. On the flip side, the NSE Insurance and NSE oil/Gas indices moderated by 0.68% and .18% respectively. Meanwhile, market activity was weak as the total volume and value of stocks traded fell by 13.24% and 38.32% to 0.35 billion units and N3.8 billion. Elsewhere, NIBOR rose for most tenor bucket amid renewed liquidity strain; however, NITTY moderated for most maturities tracked amid demand pressure . In the OTC bonds market, the values of FGN bonds rose for all maturities tracked; however, FGN Eurobond moderated for all maturities tracked.
