



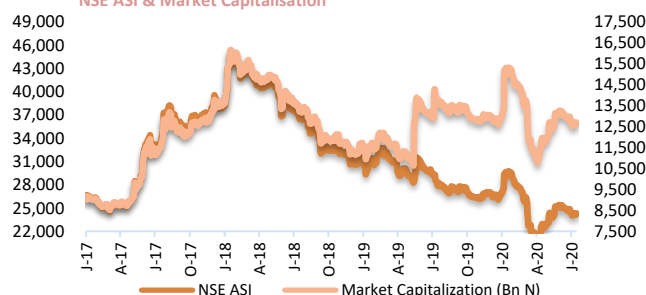

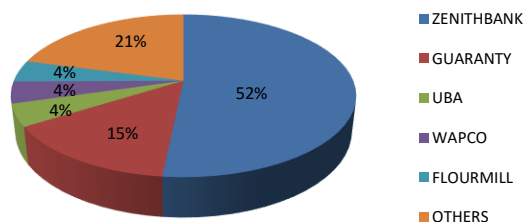
The NSE All Share Index Jumps by 2.12% amid Sustained Bullish Activity; NIBOR Declines for All Tenor Buckets amid Sustained Liquidity Ease...

The domestic equities market ASI advanced by 2.12% to close at 27,554.49 points amid sustained bargain hunting activity even as the Exchange recorded 36 gainers as against 10 losers at the close of trading session. Consequently, the year to date gain of the NSE ASI rose to 2.6%. Sentiment was positive in the market amid investors demand for blue-chip stocks such as MTNN, SEPLAT, ZENITHBANK, WAPCO and GUARANTY. Hence, their respective prices appreciated by 3.85%, 2.50%, 5.26%, 5.61% and 2.41%. Similarly, all the sub-sector gauges tracked closed in green territory; the NSE Banking, NSE Insurance, NSE Consumer Goods, NSE oil/Gas and NSE Industrial indices gained 3.37%, 2.04%, 0.38%, 0.84% and 0.38% respectively. Meanwhile, market activity picked up as the total volume and value of stocks traded ballooned by 131.98% and 158.55% to 0.60 billion units and N7.4 billion. Elsewhere, NIBOR fell for all tenor bucket amid sustained liquidity ease; however, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; however, FGN Eurobond rose for all maturities tracked.
