

Bull Sustains Grip as the NSE ASI Rises by 4.92% amid Positive Investors Sentiment; NIBOR Declines for All Tenor Buckets amid Sustained Liquidity Ease... At the end of Tuesday's trading session, the domestic equities market ASI advanced by 4.92% to close at 28,909.37 points amid sustained bullish momentum. Consequently, the year to date gain of the NSE ASI ballooned to 7.7%. Also, the Exchange recorded 41 gainers as against 7 losers. No tably, banking and industrial sector shares were the toast of investors today as Ticker such as ZENITHBANK, GUARANTY, DANGCEM and WAPCO gained 9.21%, 4.38%, 9.86% and 9.69%. Hence, the NSE Banking and NSE Industrial indices advanced the most by 7.48% and 5.64% respectively. Similarly, the NSE Insurance, NSE Consumer Goods and NSE Oil/Gas indices rose by 0.26%, 2.95% and 1.15% respectively. Meanwhile, market activity was upbeat as the total volume and value of stocks traded rose by 24.10% and 27.89% to 0.74 billion units and N9.4 billion. Elsewhere, NIBOR fell for all tenor bucket a mid sustained liquidity ease; however, NITTY rose for all maturities tracked. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; also, FGN Eurobond rose for all maturities tracked.
