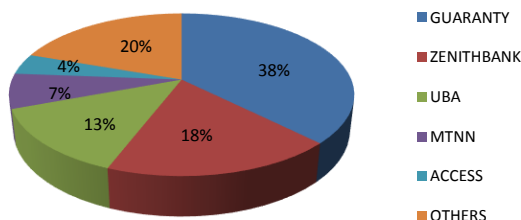
The Domestic Market Index Falls by 0.27% amid Sustained Profit Taking Activity; NIBOR Falls for All Tenor Buckets amid Sustained Liquidity Ease...

The local equities market started the week on a negative note as its ASI moderated by 0.27% to close at 28,337.39 points. Also, the Exchange printed 16 losers as against 13 gainers at the close of the trading week. Hence, the year to date gain of the NSE ASI fell to 5.5%. Notably, sell-offs on blue-chip stocks such as MTNN, BUACEMENT, FBNH and GUARANTY moderated their respective share prices by 0.36%, 1.45%, 0.81% and 0.33%. Of the five indices tracked, four closed in red territory except for the NSE Oil/Gas index which rose by 1.36%. The NSE Banking, NSE Insurance, NSE Consumer Goods and NSE Industrial lost 0.06%, 1.78%, 0.91% and 0.54% respectively. Meanwhile, market activity was mixed as the total volume of stocks traded fell by 3.90% to 0.36 billion unit; however, the value of stocks traded rose by 26.53% to N5.0 billion respectively. Elsewhere, NIBOR fell for all tenor bucket amid renewed liquidity ease; also, NITTY moderated for most maturities tracked amid demand pressure. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; however, FGN Eurobond rose for all maturities tracked.
