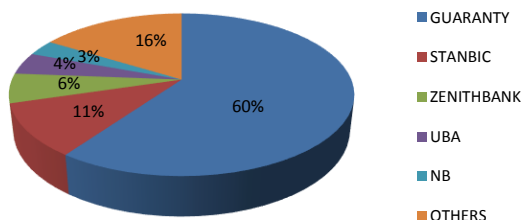
The Domestic Market Index Rebounds by 0.02% amid Renewed Bargain Hunting Activity; NIBOR Moves in Mixed Directions across Tenor Buckets...

The local equities market rose marginally by 0.02% to close at 28,344.04 points amid renewed bullish activity even as the Exchange recorded 18 gainers against 15 losers at the close of the trading week. Hence, the year to date gain of the NSE ASI rose to 5.5%. Specifically, we saw investors bought Tickers such as STANBIC, INTBREW, ZENITHBANK, FBNH. Hence, their respective share prices rose by 3.53%, 9.56%, 0.25% and 0.81%. Similarly, performance was bullish across sub-sector gauges tracked as three out of five indices closed in green: the NSE Insurance, NSE Consumer Goods and NSE Oil/Gas indices rose by 0.34%, 0.88% and 0.11% respectively. On the other hand, the NSE Banking and NSE Industrial indices moderated by 1.18% and 0.01%. Meanwhile, market activity was mixed as the total volume of stocks traded rose by 45.14% to 0.53 billion unit; however, the value of stocks traded fell by 0.81% to N5.0 billion respectively. Elsewhere, NIBOR moved in mixed directions across tenor buckets; however, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, FGN Eurobond moderated for all maturities tracked.
