

The Domestic Market Index Closes Flat; NIBOR Declines for most Tenor Buckets amid Renewed Liquidity Ease...

The domestic bourse resumed the week flattish as the NSE ASI closed flat at 28,659.07 points; albeit, the Exchange recorded 20 losers as against 17 gainers at the close of trading session. Hence, the year to date gain of the NSE ASI remained unchanged at 6.7%. Specifically, Tickers such as GUINNESS, GUARANTY, ETI and ARDOVA advanced by 4.75%, 1.98%, 1.10% and 5.83% amid investors buying interest. However, Performance was bullish across sub-sector gauges tracked as three out of five indices closed in green: the NSE Insurance, NSE Consumer Goods and NSE Oil/Gas indices rose by 1.09%, 0.88% and 0.54% respectively. On the flip side, the NSE banking and NSE Industrial indices moderated by 0.34% and 0.14% respectively. Meanwhile, market activity was weak as the total volume and value of stocks traded fell by 41.26% and 28% to 0.28 billion unit and N3.3 billion. Elsewhere, NIBOR fell for most tenor buckets amid renewed liquidity ease; however, NITTY rose for all maturities tracked. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; also, FGN Eurobond rose for all maturities tracked.
