



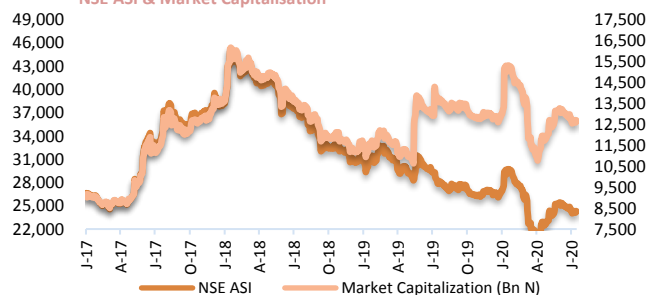

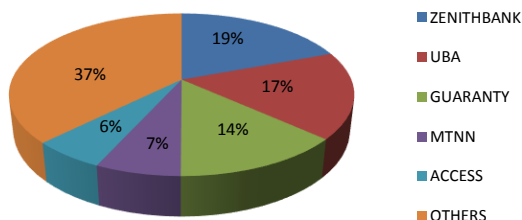
The Domestic Market Index Gains 0.03% on Consumer Goods Tickers; NIBOR Rises for all Tenor Buckets amid Renewed Liquidity Strain...

The local bourse index rose marginally by 0.03% amid renewed bullish activity; albeit, the number of losers (22) outweighed that of the gainers (19) at the close of the trading session. Consequently, the year to date gain of the NSE ASI rose to 6.8%. Despite the severity of the protest and curfew placed by Lagos state, the NSE Consumer Goods index still gained 1.86% as stocks such as NB, INTBREWE and UACN closed higher. Their respective prices rose by 4.67%, 9.39% and 1.49% respectively. On the flip side, the NSE Banking, NSE Insurance, NSE Oil/Gas and NSE Industrial indices moderated by 1.02%, 1.17%, 0.89% and 0.17% respectively. Meanwhile, market activity was mixed as the total volume of stocks traded rose by 3.48% to 0.29 billion unit; however, the value of stocks traded fell by 13.88% to N2.9 billion. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; however, NITTY fell for all maturities tracked amid demand pressure. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; also, FGN Eurobond rose for all maturities tracked.
