Domestic Equities Index Gains 0.47% amid Sustained Bullish Activity; NIBOR Falls for most Tenor Buckets amid Sustained Liquidity Ease...

The Nigerian bourse closed the week in positive territory as its index advanced by 0.47% amid sustained bargain hunting activity. Hence, the year to date gain of the NSE ASI rose to 6.9%. Also, the Exchange printed 15 gainers as against 6 losers. We saw investors patronized the blue-chip stocks amid recent declining prices/ Specifically, stocks such as ZENITHBANK, WAPCO and UBA appreciated by 2.18%, 1.42% and 4.41% respectively. Performance across sub-sector gauges tracked was bullish as four out of five indices tracked closed in green: the NSE Banking, NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices rose by 1.69&, 0.20%, 0.03% and 0.46% respectively. On the flip side, the NSE Insurance index fell by 0.12%. Meanwhile, market activity was weak as the total volume and value of stocks traded declined by 9.11% and 5.64% to 0.28 billion unit and N4.4 billion. Elsewhere, NIBOR fell for most tenor buckets amid sustained liquidity ease; also, NITTY moderated for all maturities tracked amid demand pressure. In the OTC bonds market, the values of FGN bonds moderated for maturities tracked; however, FGN Eurobond rose for most maturities tracked.
