



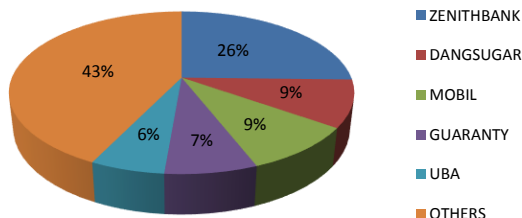
Local Bourse Index Sheds 0.17% amid Renewed Profit Taking Activity; NIBOR Rises for most Tenor Buckets amid Sustained Liquidity Strain...

The local bourse started the week on a negative note as its All Share Index (ASI) moderated by 0.17% to close at 30,479.39 points amid renewed bearish activity. Hence, the year to date gain of the NSE ASI fell to 13.55%. Also, the numbers of losers (26) outweighed that of the gainers (21) as investors sold part of their holdings to book profit given the recent price increase. Hence, Tickers such as UBA, MOBIL, ZENITHBANK and JBERGER moderated by 0.65%, 3.11%, 0.68% and 2.52% respectively. Of the five indices tracked, three closed in red; the NSE Banking, NSE Oil/Gas and NSE Industrial indices declined by 0.78%, 1.21% and 0.06% respectively. On the positive side, the NSE Insurance and NSE Consumer Goods rose by 0.70% and 0.53% respectively. Meanwhile, market activity was weak as the total volume and value of stocks traded fell by 53.37% and 63.79% to 0.37 billion unit and N3.8 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid sustained liquidity strain; however, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions; however, FGN Eurobond moderated for all maturities tracked.
