

Local Bourse Index Rebounds by 0.83% amid Renewed Bullish Activity; NIBOR Rises for all Tenor Buckets amid Sustained Liquidity Strain...

The local bourse All Share Index (ASI) rose by 0.83% to close at 30,733.47 points amid renewed bargain hunting activity even as the Exchange printed 22 gainers as against 19 losers at the close of the trading session. Hence, the year to date gain of the NSE ASI notched higher to 14.49%. Notably, investors buy interest in Counters such as DANGCEM, CAP, ACCESS and OANDO lifted their respective prices by 5.63%, 9.58%, 1.26% and 7%. Performance across subsector gauges tracked was bullish as three out of the five indices tracked closed in green; the NSE Insurance, NSE oil/Gas and NSE Industrial indices rose by 0.33%, 0.62% and 2.85%. On the flip side, the NSE Banking and NSE Consumer Goods indices fell by 0.47% and 0.13% respectively. Meanwhile, the total volume of stocks traded fell by 10.77% to 0.33 billion unit; however, the value of stock traded rose by 2.32% to N3.8 billion respectively. Elsewhere, NIBOR rose for all tenor buckets amid sustained liquidity strain; however, NITTY moderated for most maturities tracked amid demand pressure. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, FGN Eurobond rose for all maturities tracked.
