## Cowry Daily Market Insight 05 November 2020

Local Bourse Index Falls by 0.01% amid Renewed Bearish Activity; NIBOR Falls for all Tenor Buckets amid Sustained Liquidity Ease...

The local bourse All Share Index (ASI) moderated by 0.01% to close at 30,738.92 points amid renewed profit taking activity; albeit, the Exchange printed equal (16) number of gainers and losers at the close of the trading session. Hence, the year to date gain of the NSE ASI lowered to 14.51%. Notably, sell-offs on Counters such as BUACEMENT, ETI and FLOURMILL moderated their respective share prices by 0.11%, 0.97% and 2.82% respectively. However, Sectorial Performance moved in different directions; the NSE Banking and NSE Oil/Gas indices rose by 0.06% and 0.04% respectively while the NSE Insurance and NSE Consumer Goods indices declined by 0.65% and 0.53% respectively. The NSE Industrial index closed flat. Meanwhile, market activity was upbeat as the total volume and value of stocks traded rose by 50.16% and 113.89% to 0.43 billion units and N6.6 billion respectively. Elsewhere, NIBOR fell for all tenor buckets amid sustained liquidity ease; however, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, FGN Eurobond rose for all maturities tracked.
