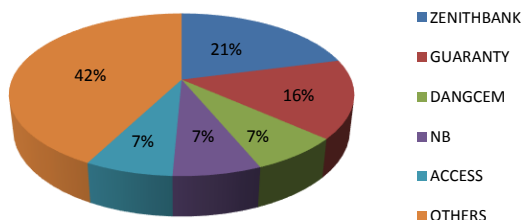
## Local Bourse Index Rises by 1.25% amid Sustained Bullish Activity; NIBOR Falls for most Tenor Buckets amid Renewed Liquidity Ease...

The local bourse All Share Index (ASI) climbed by 1.25% to close at 32,647.10 points amid sustained bullish activity even as the Exchange printed 39 gainers against 11 losers at the close of trading session. Hence, the year to date gain of the NSE ASI rose to 21.62%. Sentiment remain positive in the market as Tickers such as MTNN, BUACEMENT, ZENITHBANK, STANBIC and ETI closed higher by 4.06%, 1.11%, 2.30%, 4.35% and 3.33% respectively. Also, all the sub-sector gauges tracked closed in green; the NSE Banking, NSE Insurance, NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices rose by 0.93%, 3.28%, 0.75%, 1.32% and 0.22% respectively. Meanwhile, market activity waned as that total volume and value of stocks traded moderated by 9% and 6.08% to 0.57 billion units and N7.7 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid renewed liquidity ease; however, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; also, FGN Eurobond declined for all maturities tracked.
