Local Bourse Index Rises by 1.90% amid Sustained Bullish Activity; NIBOR Moves in mixed direction across Tenor Buckets...

The local bourse All Share Index (ASI) advanced by 1.90% to close at 32,268.36 points amid sustained bullish activity even as the Exchange printed 51 gainers as against 7 losers at the close of trading session. Hence, the year to date gain of the NSE ASI rose to 23.94%. Specifically, the NSE banking index increased by 4.07% as investors demanded more for banking stocks thus lifting the share prices of ZENITH, UBA, ACCESS and GUARANTY by 4.49%, 3.41%, 4.49% and 2.86% respectively. Similarly, other sub-sector gauges tracked closed in green; the NSE Insurance, NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices gained 1.19%, 2.56%, 1.27%, and 1.14% respectively. Meanwhile, market activity was upbeat as that total volume and value of stocks traded rose by 48.27% and 17.04% to 0.85 billion units and N9.0 billion respectively. Elsewhere, NIBOR moves in mixed directions across tenor buckets; however, NITTY moderated for all maturities tracked amid demand pressure. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, FGN Eurobond rose for all maturities tracked.
