

Cowry Daily Market Insight 17 November 2020

MPR: 11.50% Oct '20 Inflation Rate: 14.23% Q2 2020 Real GDP: -6.1%

The Domestic Equities Market Index Sheds 1.59% amid Sustained Profit Taking Activity; NITTY Falls to Negative Rates for most Tenor Buckets... The local Bourse ASI moderated by 1.59% to close at 34,242.83 points amid sustained bearish activity, especially on bellwethers. Also, the Exchange recorded 30 losers as against 17 gainers at the close of trading session. Hence, the year to date gain of the NSE ASI plummeted to 27.57%. Notably, Bellwethers such as NESTLE, DANGCEM, ACCESS and ZENITHBANK experienced decline in share prices as investors continue to book profit. Hence, their respective prices moderated by 3.45%, 6.45%, 3.45% and 0.38% respectively. Of the five indices tracked, four closed in red except for the NSE Banking index which rose by 0.75%. The NSE Insurance, NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices fell by 2.17%, 3.21%, 0.87% and 3.33% respectively. Meanwhile, market activity was upbeat as the total volume and value of stocks traded ballooned by 1300.09% and 53.15% to 0.936 billion units and N12.02 billion. Elsewhere, NIBOR fell for all tenor buckets; however, NITTY fell to negative rates for most tenor bucket amid demand pressure. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, FGN Eurobond fell for all maturities tracked.
