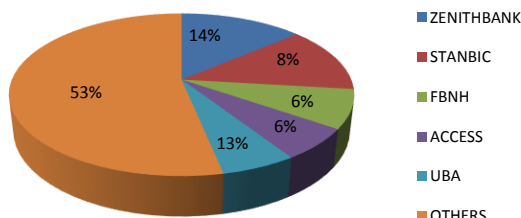
The Lagos Bourse Index Falls by 0.50% amid Renewed Bearish Activity; NIBOR Closes Flat for most Tenor Buckets...

The local Bourse All Share Index declined by 0.50% to close at 34,643.65 points amid renewed profit taking activity even as the Exchange printed 29 losers against 17 gainers at the close of trading session. Hence, the year to date gain of the NSE ASI moderated to 29.06%. Specifically, the NSE Banking index fell by 2.66% even as GUARANTY released its unaudited nine months group financial statements. Banking shares such as STANBIC, GUARANTY, ACCESS, ZENITHBANK and STERLNBANK declined by 4.12%, 2.70%, 0.58%, 1.87% and 2.87% respectively. On the positive side, the NSE Insurance, NSE Consumer Goods and the NSE Industrial indices rose by 1.52%, 0.44% and 0.33% respectively. The NSE oil/Gas index closed flat. Meanwhile, the total volume and value of stocks traded fell by 44.80% and 57.80% to 0.36 billion units and N3.5 billion respectively. Elsewhere, NIBOR closed flat for all tenor buckets; however, NITTY moved in mixed directions across tenor bucket even as most maturities traded within negative territory. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; also, FGN Eurobond fell for most maturities tracked.
