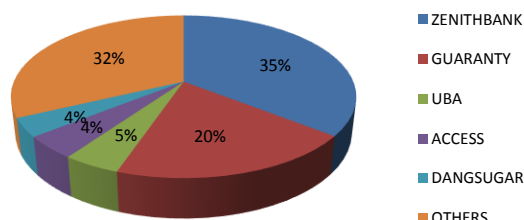
Lagos Bourse Index Rebounds by 0.65% amid Renewed Bullish Activity; NIBOR Rises for most Tenor Buckets amid Renewed Liquidity Strain...

The local Bourse All Share Index (ASI) rose by 0.65% to close at 34,340.56 points amid renewed bargain hunting activity even as the Exchange printed 24 gainers as against 17 losers at the close of trading session. Hence, the year to date gain of the NSE ASI rose to 27.93%. Notably, share prices of Tickers such as WAPCO, UBA, FBNH and GUARANTY advanced by 0.91%, 6.49%, 6.72% and 0.29% respectively amid buy pressure. Performance was also bullish across sub-sector gauges tracked as all of the indices tracked closed in green; the NSE Banking, NSE Insurance, NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices appreciated by 2.16%, 2.02%, 0.10%, 0.03% and 0.06% respectively. Meanwhile, market activity was weak as the total volume and value of stocks traded fell by 35.67% and 35.96% to 0.36 billion units and N4.6 billion. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; however, NITTY fell for most tenor bucket amid demand pressure. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, FGN Eurobond rose for all maturities tracked.
