

NSE ASI Increases by 0.45% on Sustained Bargain Hunting; NITTY Rises for All Maturities Tracked on Renewed Bearish Activity...

The local bourse resumed the week on a positive note as its All Share Index (ASI) increased by 0.45% amid sustained bargain hunting activity. Hence, the year to date gain of the NSE ASI hit 30.55%. Despite the bullish activity, the Exchange printed a higher number of losers (29) than gainers (19) even as three of the five sub-sector gauges closed in negative. Banking sector was most hit as its index fell by 2.49%; also, the NSE Industrial and the NSE Consumer Goods declined by 0.68% and 0.44% respectively. On the positive side, the NSE Insurance and the NSE Oil/Gas indices rose by 1.63% and 0.01% respectively. Meanwhile, we saw improve liquidity in the equity today as the deals, total volume and value of stocks traded rocketed by 32.47%, 118.38% and 47.05% to 5,267 deals, 0.42 billion units and N4.89 billion respectively. Elsewhere, NIBOR moved in mixed directions across tenor buckets tracked; however, NITTY rose for all maturities tracked amid renewed bearish activity. In the OTC bonds market, the values of FGN bonds remained flattish for most maturities tracked; however, FGN Eurobond moderated for all maturities tracked amid bearish activity.
