**Bullish Local Equities Market Mellows by 0.26% Today as Investors Take Profit; NITTY Moderates for All Maturities Tracked on Sustained Demand Pressure...**

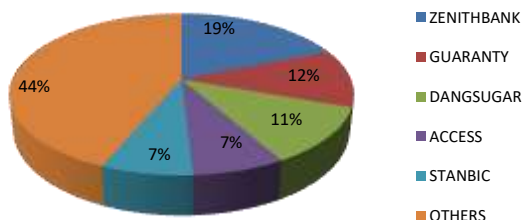
The NSE All Share Index (ASI) moderated by 0.26% today as banking shares, especially ZENITH and GUARANTY, declined by 1.64% and 2.86% respectively. Also, investors priced lower the shares of FLOURMILL, DANGSUGAR and UACN despite the increased liquidity flow witnessed today. Given the renewed bearish activity, the Exchange printed more losers (22) than gainers (19) even as most of the sub-indices closed southwards. The NSE Consumer Goods, NSE Banking, NSE Oil/Gas and the NSE Industrial indices fell by 1.81%, 0.80%, 0.72% and 0.02% respectively. Hence, the year to date gain of the NSE ASI mellowed to 30.60%. Meanwhile, activity in the market was upbeat as the deals, total volume and value of stocks traded jumped by 1.84%, 19.72% and 61.37% to 4,598 deals, 0.37 billion units and N5.49 billion respectively. Elsewhere, NIBOR rose for all tenor bucket tracked amid renewed liquidity strain. NITTY moderated for all maturities tracked amid renewed demand pressure. In the OTC bonds market, the values of FGN bonds moved in mixed directions; albeit we saw a spike in yield on FGN Bond 2037 maturity. Nonetheless, the value of FGN Eurobond increased for all maturities tracked amid sustained bullish activity.
