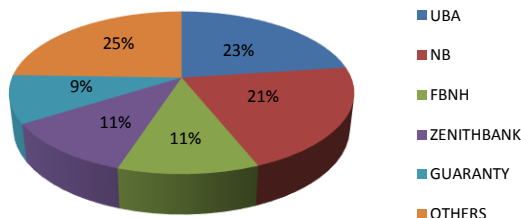
## Local Bourse Index Falls by 0.21% amid Renewed Bearish Activity; NIBOR Rises for Most Tenor Buckets on Renewed Liquidity Strain...

The Lagos bourse began the week in negative territory as its All Share Index (ASI) moderated by 0.21% to close at 35,064 points. Hence, the year-to-date gain of the NSE ASI lowered to 30.63% albeit the Exchange recorded a higher number of gainers (17) than losers (14). Notably, investors sold off part of their holdings in blue-chip companies like WAPCO, ZENITHBANK and GUARANTY; hence their respective share prices declined by 0.87%, 1.04% and 0.30%. Of the five indices tracked, three closed northwards; the NSE Banking, NSE Consumer Goods and NSE Industrial indices moderated by 0.84%, 0.56% and 0.07% respectively. On the positive side, the NSE Insurance and NSE oil/Gas indices rose by 0.48% and 0.17% respectively. Meanwhile, the volume of stocks traded rose by 10.74% 0.32 billion units; however, total value traded fell by 25.52% to N0.31 billion. Elsewhere, NIBOR rose for most tenor bucket amid renewed liquidity strain; also, NITTY rose for all maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, the value of FGN Eurobond moderated for most maturities tracked amid renewed bearish activity.
