
Nigerian Equities Market Index Moderates by 0.94% on DANGCEM Shares; NIBOR Declines for Most Tenor Buckets on Renewed Liquidity Ease...

The domestic equities market closed the week southwards as its index fell by 0.94% to close at 34,250.74 points. Hence, the year-to-date gain of the NSE ASI fell to 27.60% despite the Exchange printing 28 gainers as against 7 losers at the close of trade. Specifically, share prices of Tickers such as DANGCEM, JBERGER, GLAXOSMITH and UNILEVER plummeted by 8.04%, 4.62%, 2.99% and 1.15% respectively. However, performance across sub-sector gauges didn't mirror the overall market performance as all the sub-indices tracked closed positive except for the NSE Industrial index which fell by 4.09%. The NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Oil/Gas indices fell by 2.54%, 2.10%, 0.18% and 0.37% respectively. Meanwhile, activity in the market was mixed as total deals and value of stocks traded declined by 25.32% and 32.74% to 4,810 deals and N4.4 billion respectively. However, the volume of stocks traded rose by 43.71% to 0.79 billion units. Elsewhere, NIBOR fell for most tenor bucket amid renewed liquidity strain; however, NITTY rose for most maturities tracked as investors demanded for better yield. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; however, the value of FGN Eurobond rose for most maturities tracked.
