

Bull Maintains Dominance as Local Bourse Index Jumps by 2.40%; NIBOR Moderates for most Tenor Buckets amid Sustained Liquidity Ease... The domestic equities market All Share Index (ASI) rose by 2.40% to 38,803.74 points amid sustained bargain hunting activity even as the Exchange recorded 26 gainers as against 7 losers at the close of trading session. Hence, the year-to-date gain of the NSE ASI advanced to 44.56%. Sentiment remained positive in the market as investors demanded more of blue-chip stocks such as AIRTELAFRI, BUACEMENT and UBA. Hence, their respective shares rose by 9.99%, 9.09% and 1.19%. Of the five indices tracked, three closed in green while others moved in mixed directions. The NSE Banking, NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices rose by 0.18%, 0.40% and 3.10% respectively. However, the NSE Insurance index fell by 0.81% while the NSE oil/Gas closed flat. Meanwhile, activity in the market was upbeat as the total volume and value of stocks traded rocketed by 238.56% and 82.24% to 1.49 billion units and N18.74 billion respectively. Elsewhere, NIBOR moderated for most tenor bucket amid sustained liquidity ease; however, NITTY rose for all maturities tracked. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; however, the value of FGN Eurobond rose for most maturities tracked.
